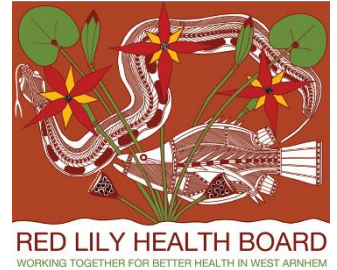

## **OUR VISION**

The Red Lily Health Board story is about threat, survival, re-emergence, and growth.

Through our strong leadership we will grow. This re-emergence and growth will be driven by our people to encourage pride and empowerment within our communities.

Our Vision acknowledges the distinct and diverse identity of our people and their communities.

Governance is a non-Indigenous term applied to many concepts relating to fair and open practices, and sound and informed decision making.

For Bininj/Arrakpi people the term governance has a much wider implication as it informs every aspect of their cultural, spiritual, and interpersonal relationships.

For Bininj/Arrakpi people governance is called Iwarruidj.

It is with Iwarruidj in mind that the Red Lily Health Board's vision, objectives, and representative model have been developed.

## **OUR MAIN GOALS**

- To improve the access to primary health care for all people living in the West Arnhem region
- To ensure the health services are providing the best health service and is culturally appropriate for all clients.
- Attract and employ suitably qualified health workers.
- Provide leadership and support to the young people of the region.
- To work in close partnership with health bodies, governments, industry groups and community organisations
- To advocate and lobby on behalf of the people of the region.
